
The Network of GPS Stations - SIGNAL

Slovenia-Geodesy-NAvigation-Location

- 15 GPS stations, 1 center of GPS Service
- Established in year 2006
- Fully functional since December 2006


Fundamental infrastructure for positioning in the new coordinate system.


Single station

The Transformation of Data

- Transformation parameters based on ETRS-points (different levels)
- Detail transformation parameters based on local points (not measured by SMA)
- Transformation models for transformation of all SMA databases (testing phase)



The New Cartographic Projection


- Transverse Mercator Projection
- New ellipsoid: GRS80
- Latitude of projection origin: 0°
- Longitude of central meridian: 15°



- False northing: -5.000.000 m
- False easting: 500.000 m
- Scale factor: 0,9999

The Height System

- Study of the new height system
- Proposal of the new high precision levelling network (2000 km)
- New tide gauge station (mareograf Koper), part of ESEAS




The New Gravimetric Network



- Establishment of new gravimetric points
- Relative measurement of points in 2006

Points:

- 6 absolute
- 29 relative



The Project


Establishment of the Network of GPS Stations and European Spatial Reference System in Slovenia

- **Grant Agreement with Norwegian Financial Mechanism (financial donation)**
- **Overall Objectives:** to establish a modern national geoinformation infrastructure
- providing conditions for determining position in ESRS with GPS in the entire state territory
- **higher quality of spatial data (long-term)**



The Recording of the Real Estate Act

- All updates in Land Cadastre will be determined and will be recorded in the new coordinate system after 1st January 2008.
- The Land Cadastre database will be maintained in the existing (old) and in the new coordinate system (creation of new data layer).
